## ***Trainer's Corner***

**Employers are responsible for ensuring that workers use seatbelts.**

Under Ontario's Occupational Health and Safety Act (OHSA) and CSA B335, every sit down counterbalanced lift truck must be fitted with a restraint system and operators are required to use it. Here's why wearing the provided seatbelt is non negotiable:

### **Life Saving in a Rollover**

In the unlikely event of a tip over, your seatbelt holds you securely inside the operator's protective cage preventing ejection and drastically reducing the risk of serious injury or fatality.

### **Keeps You in the Protective Zone**

The overhead guard alone can't stop you from bouncing out. The belt ensures you remain within the safeguarded "operator's compartment" where the structure is designed to protect you.

### **Bridges a 100 Year Old Design to Today's Safety Needs**

The counterbalance principle hasn't changed much since the earliest forklifts. Today's belts and overhead guards are engineered to compensate when someone misjudges speed, load height or turning radius.

### **Three Point Stability—not Four**

Though it has four wheels, a sit down counterbalance forklift actually pivots on three points of contact. That makes it inherently less stable in corners or on uneven surfaces than a car or truck. Your belt becomes the final line of defense.

### **Legal Requirement**

Under OHSA and its regulations, employers must ensure all safety devices are used. CSA B335 recommends, and in many cases mandates, operator restraint. Failure to buckle up can lead to orders, fines, and most importantly, preventable harm.

**Bottom Line:** Be sure that your employees buckle their seatbelt at all times while operating. It's the simplest action they can take to protect their life, their health, and your compliance record.
